Enclosed is the Form 990 of Blessed Be Hope For Three, Inc. (dba Hope For Three) for the fiscal year ended December 31, 2025. The figures below are drawn from our audited financial statements for the same year, on which KenWood & Associates, P.C., of Sugar Land, Texas, issued an unmodified, clean opinion dated May 8, 2026, with no material findings and no going concern. Subsequent events were evaluated through that date.

FY 2025 results. Total revenue and support were \$719,127, and total expenses were \$796,661, resulting in an operating deficit of \$77,534. Ending net assets, all without donor restrictions, were \$278,968. The deficit reflects softer philanthropic conditions in FY 2025 across foundation, corporate, and individual giving. Programs continued without interruption under the active oversight of the Board of Directors and the Finance Committee.

Management's response. During FY 2025, management eliminated one salaried position, did not renew one contractual role, tightened expense controls, and enhanced cash-flow forecasting. The board-approved FY 2026 budget of \$800,266, prepared by management, projects a modest operating surplus.

Financial position at year-end (from the audited statements):

1. **Liquidity.** Total financial assets \$503,627. Financial assets available for general expenditure within one year \$405,828 (Note 3), about 6.1 months of average monthly expenses. Year-end cash was \$488,113.
2. **Program focus.** 70.1% of total expenses went directly to program services (\$558,665 of \$796,661), above the 65% program-expense standard used by the BBB Wise Giving Alliance.
3. **Revenue mix.** Multiple streams: foundation grants \$308,256 (43%), fundraising events \$285,802 (40%), contributions \$116,380 (16%), program revenue \$5,000, and interest \$3,689. Foundation concentration is disclosed in Note 10.
4. **Governance.** Management reports 92% board participation in annual giving for FY 2025, with total board contributions of about \$19,000 (Note 11). No board member or employee family member received Family Assistance funding in FY 2025.

Mission impact since 2012. Hope For Three has directed more than \$2.1 million to approved healthcare providers, treatment facilities, therapy vendors, and diagnosticians on behalf of families affected by autism in Fort Bend County and the Greater Houston area. Under the Family Assistance and Resource Support (FARS) program, payments are made directly to vetted professionals on behalf of families. The money never touches a family's hands.
